AN ORDINANCE AMENDING §34.55 OF THE CODE OF ORDINANCES OF THE MUNICIPALITY OF NEW LEBANON.

WHEREAS, §34.55 of the Code of Ordinances of the Municipality of New Lebanon which reads as follows:

§ 34.55 BUILDINGS FOR DEPARTMENT; REGULATIONS FOR USE OF FIRE STATION.
(current)

(A) Council may provide or erect necessary and suitable buildings containing rooms for fire engines and other equipment, and provide for the meetings of the fire and hose companies.

(R.C. § 737.25) ('80 Code, § 34.25)

(B) The Council hereby adopts the following regulations of usage for the new municipal fire station, to be conspicuously posted in the Fire Station and freely disseminated, without charge, to all users of the municipal Fire Station:

(1) All types of smoking will be permitted in designated areas only.

(2) Kitchen facilities are not available.

(3) Storage of any type of property is prohibited, except for the various municipal departments.

(4) All trash from usage of the facility must be properly disposed of immediately.

(5) All rooms and equipment must be returned to the condition in which they were found.

(6) Fire Department and all other official municipal functions take precedence over all other scheduled or unscheduled users and uses.

(7) Any non-official group seeking to use the facility shall execute an agreement to abide by these regulations prior to any usage.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Municipality of New Lebanon, Ohio, that §34.55 IS HEREBY AMENDED TO READ

§ 34.55 BUILDINGS FOR DEPARTMENT; REGULATIONS FOR USE OF FIRE STATION.

Council may provide or erect necessary and suitable buildings containing rooms for fire engines and other equipment, and provide for the meetings of the fire and hose companies.

SECTION 1: This ordinance shall take effect and be in force from and after the earliest period by law.




