**A RESOLUTION: AUTHORIZING THE ACTING VILLAGE MANAGER TO ENTER INTO A CONTRACT FOR EMS BILLINGS SERVICES.**

**WHEREAS**, the Village of New Lebanon recognizes the critical importance of providing efficient and effective Emergency Medical Services (EMS) to its residents; and

**WHEREAS**, the billing services for such EMS are essential for the recovery of costs associated with providing these lifesaving services; and

**WHEREAS**, the prior contract for EMS billing services was terminated by the Change Healthcare, leaving the Village without the necessary support for EMS billing; and

**WHEREAS**, it is in the best interest of the Village and its residents to ensure that there is no interruption in EMS billing services; and

**WHEREAS**, the Acting Village Manager and Fire Chief have conducted a thorough evaluation of potential EMS billing service providers and has recommended entering into a contract with Ambulance Billing Network (ABN);

**NOW, THEREFORE, BE IT RESOLVED** by the Village Council of New Lebanon, Ohio, that:

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF NEW LEBANON, MONTGOMERY COUNTY, OHIO, AS FOLLOWS:**

**SECTION I**           The Village Council hereby authorizes the Acting Village Manager to negotiate and enter into a contract with Ambulance Billing Network (ABN) for the provision of EMS billing services.

**SECTION II**          The Village Manager is further authorized to take all necessary actions to execute and implement the contract, including the allocation of budgetary resources within the approved budget for 2024.

**SECTION III**         The contract shall include terms and conditions that protect the Village's interests, ensure compliance with all applicable laws and regulations, and provide for termination clauses, service level agreements, and confidentiality provisions as deemed necessary by the Village Manager and the Village's legal counsel.


**SECTION IV**


