Mayor Arriola stated next is the FIRST READING ORDINANCE 2022-03: AN ORDINANCE CERTIFYING THE MUNICIPALITY OF NEW LEBANON DISTRIBUTION YEAR 2023 STREET LIGHT ASSESSMENT TO MONTGOMERY COUNTY, OHIO, IN THE AMOUNT OF \$60,000.00.

Mayor Arriola stated this is the first reading. Are there any questions?

Council Member Perkins asked is it more this year than it was last year?

Municipal Manager Madden stated last year it was \$57,750; the year before it was \$61,975; and the year before that it was \$67,725.

Mayor Arriola stated next is the FIRST READING ORDINANCE 2022-04: AN ORDINANCE ENACTING AND ADOPTING A SUPPLEMENT TO THE CODE OF ORDINANCES FOR THE MUNICIPALITY OF NEW LEBANON.

Council Member Joy stated these are all the changes that have been made in 2021.

Municipal Manager Madden stated yes. They are enacted. We do this once a year to clean everything up.

Council Member Loch asked are there any other changes?

Municipal Manager Madden stated we can't unless you guys vote on them. These are just our Ordinances that were changed.

## **Public Comments or Questions**

Mayor Arriola stated we don't have any public comments.

#### ADMINISTRATIVE STAFF COMMENTS

Mayor Arriola stated Police Chief.

Police Chief Hensley stated I have nothing.

Mayor Arriola asked anything for the Police Chief.

Council Member Adkins stated I know you guys have seen it all over social media about the guy that is driving a Pontiac. You guys had an encounter with him. We actually had the same encounter that night when the police was chasing him. Perry Township actually almost ran over him when they were doing the high speed chase. We have actually seen him going into his trunk. It has been posted on social media he actually has a gun. I know one of the police officers has talked with him about it. They said Perry Township has it on record with the license reader. Has anybody talked to him about acting as if he has a gun on social media or has anyone called you about what is going on?

Police Chief Hensley stated no one has called our office about anything like that. Apparently a couple of people made threats to him that they had a firearm and he said I have got one too. None of that is official. Until we have a valid complaint from someone other than what they have read on social media or heard from someone there is not much we can do.

Council Member Adkins stated I know he is still speeding down Route 35 because my house is right there and I just tell everyone to stay away from that you know. I keep my dogs a little bit further away now because I don't want them to get hit.

Police Chief Hensley stated we watch for anyone who is speeding up and down Route 35. We have not had an encounter with him speeding yet, but if we do he will receive due attention. We are aware of it.

Mayor Arriola stated anyone have anything for the Police Chief. Nothing voiced.

Mayor Arriola stated Fire Chief Keyser.

Fire Chief Keyser stated last year we put in for Fire Grants through Department of Home Land Security/Fema. They started distributing awards about a month ago. Week one we received \$261,500 for new air paks, a vehicle exhaust system for the station, and a new cascade fill station for the air paks. Week 3 we received another \$481,500 for a new tanker. In 2017 we got a vehicle which was my second vehicle in 5 years through Fema with total awards about \$850,000 over the last 5 years.

Mayor Arriola stated that is great.

Fire Chief Keyser stated just so everyone understands that is total so we owe 5 percent of that; 5 percent of \$743,000 is what we will pay.

Municipal Manager Madden stated we budgeted a whole lot more for a tanker.

Fire Chief Keyser stated that is probably going to save us \$550,000 just for that truck.

Mayor Arriola stated that is great.

Mayor Arriola stated any questions for the Fire Chief.

Mayor Arriola asked what happened to the glass in front of the firehouse.

Fire Chief Keyser stated the door failed and fell on top of the truck. We are just waiting on a new door. It is like everything else, the price fluctuates week to week with the wait time anywhere from 6 to 10 months.

Mayor Arriola stated anything from Code Enforcement Administrator Melody this evening.

Municipal Manager Madden stated nothing this evening.

Mayor Arriola stated anything to pass on the Melody. Nothing voiced.

Mayor Arriola stated anything from Chief Financial Officer Hinson besides the motion.

Municipal Manager Madden stated just the motion.

Mayor Arriola stated do I have motion to adopt the August 2022 Financial Report.
