**AN ORDINANCE TO SUPPLEMENT APPROPRIATIONS IN THE CAPITAL
IMPROVEMENT FUND FOR THE PURCHASE OF POLICE RADIOS AND
DECLARING AN EMERGENCY.**

WHEREAS, Ohio Revised Code § 5705.40 authorizes the legislative authority of a political subdivision to amend or supplement appropriations during the fiscal year, provided the entity complies with the same provisions of law as are applicable to the original appropriation and the total appropriations from each fund do not exceed the official certificate of estimated resources or any amendment thereof certified for the current fiscal year; and

WHEREAS, the Village Police Department has identified an immediate need to replace and upgrade portable and in-car radio equipment to maintain reliable communication with dispatch and regional law-enforcement partners; and

WHEREAS, the current capital appropriation does not contain sufficient funds to cover this necessary purchase; and

WHEREAS, the Village has available unappropriated fund balance or other revenue sources in Fund D03 sufficient to support this supplemental appropriation without exceeding the certified resources for fiscal year 2025; and

WHEREAS, delay in approval could impair emergency response and officer safety; and

WHEREAS, Council therefore finds it necessary to supplement the current year appropriations for the Capital Improvement Fund (Fund D03) to authorize this expenditure;

NOW, THEREFORE, BE IT ORDAINED by the Village Council of New Lebanon, Ohio, that:

SECTION I To provide for current expenses and other expenditures of the Village of New Lebanon during fiscal year 2025, the following supplemental appropriations are hereby made:

FUND	DESCRIPTION	AMOUNT
Capital Improvement Fund (D03)	Police Radio Replacement Project	\$ 76,400.00

SECTION II

The Fiscal Officer is authorized and directed to record this appropriation in the Village's accounting system, to make all necessary budget adjustments to reflect this supplemental appropriation, and to file a copy of this ordinance with the County Auditor as required by Ohio Revised Code § 5705.40.

SECTION III

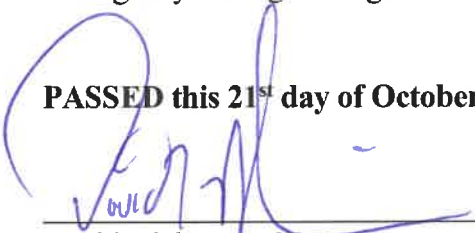
It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were adopted in an open meeting, and that all deliberations of this Council and of its committees were conducted in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

SECTION IV

This ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of the Village and its citizens, to ensure the Police Department maintains safe and effective communication capabilities essential to emergency response. Therefore, this ordinance shall take effect immediately upon its passage.

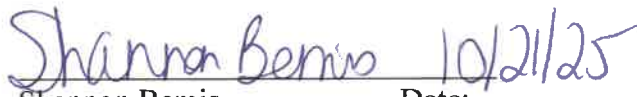
