The Meeting was called to order at 7:38pm by Mayor Arriola. The invocation was given followed by the Pledge of Allegiance.

Police Presentation of Promotions.

Police Chief Hensley presented Sergeant Oney with his promotion and swore in Officer Kaczmarek and Officer Morgan.

Review of Findings.

Law Director mentioned several requests brought up at and after the last meeting to do investigations. Council Member Joy was requested by a member of the public to be suspended or removed and no evidence or reason was provided. Council Member Sands was requested by a member of the public to be suspended or removed and no reason specifically was provided. Council Member Sands has resigned, so no further action needs to be taken. An investigation was requested into why a member of council could sit on the Charter Review Board, as a conflict of interest was postulated. However, it was found that he could not have benefited in any way; therefore no conflict of interest was found. An investigation was also requested to look into a conflict of interest for Council Member Joy by the Ethics Commission and by the Law Director. The contact for the Ethics commission reported there was not enough there to do an investigation based on the allegations made. The Ethics Commission did furnish the Village with citations from opinions and orders that were made by the Ohio Ethics Commission and indicated there was nothing there to do, so the press release was released that stated there were no violations of ethics. The Ohio Ethics Commission does not render an opinion to the public unless there's something to render. An investigation was conducted by the Law Director into the reported conflict of interest of Council Member Joy and his daughter being employed by the Village, and after speaking to both of them and the former and current manager, no conflict of interest was found.

Council Member Adkins brought up the situation that happened at the last meeting with Council Member Sands making claims about her and shared her grievance to Council and requested for

the minutes from the last meeting minutes to be changed to reflect the apology Council Member Sands made to her in the meeting.

Christopher Sands has tendered his resignation as a New Lebanon Council Member.
